Confidentiality Agreement (hereinafter the ‘Confidentiality Agreement’)

Subject: Confidentiality Agreement relating to the contract...

Dear Madam,

In connection with the tender procedure for project management services relating to the refurbishment of the AFD Group's office spaces, XXX, having been selected to submit a tender for the award of the contract for the project in question (hereinafter the “Proposed Transaction”), we have received and will receive information communicated in writing, verbally or by any other means (all such information and documents being hereinafter referred to as the “Information”), as well as documents including all reports, analyses, data, studies or other work based in particular on the aforementioned information (hereinafter the “Documents”) relating to the Proposed Transaction.

We undertake, both to you and to your principals and agents, on our own behalf and on behalf of our directors, employees, employee representative bodies, representatives and advisers who may become aware of the Proposed Transaction, the Information and the Documents in the course of their duties (hereinafter the “Representative(s)”), to maintain the confidentiality of the Proposed Transaction and the Information and Documents and, unless you have given your prior written consent, not to disclose them, in whole or in part, in any manner whatsoever, to any third party outside the scope of this Confidentiality Agreement.

We also undertake not to directly or indirectly disclose, copy, reproduce or distribute the Information and Documents, but to restrict their disclosure solely to those Representatives who need access to them in order to evaluate the Proposed Transaction, provided that they are made aware of the confidential nature of the Information and undertake to comply with this Confidentiality Agreement by signing a copy thereof.

We are aware that you attach great importance to this Confidentiality Agreement and to the fact that the Information and Documents are treated with the strictest confidentiality, including by our internal bodies. You have drawn our attention to the fact that any breach of this Confidentiality Agreement by us or our Representatives could undermine the Proposed Transaction itself and cause significant harm to your company.

We undertake to use the Information and Documents solely for the purpose of assessing the feasibility of the Proposed Transaction and not to use or authorise the use of the Information and other Documents for any purpose detrimental to AFD.

Upon your written request, we undertake to return all Documents provided to you without retaining any copies, with the exception of those that must be retained in accordance with legal or regulatory obligations.

The above obligations do not apply:

- to Information and Documents that are already in the public domain at the time of disclosure or that may subsequently become so without any breach on our part of our obligations;
- to Information and Documents already lawfully in our possession on the date of disclosure;
- to Information and Documents that have been disclosed as required by a law, decree, regulation or court order, provided that (i) such disclosure is strictly necessary to comply with

court orders or legal or regulatory provisions and (ii) that the party required to disclose such Information or Documents has informed AFD thereof to enable it to take any precautionary measures where necessary.

No representation or warranty is given as to the achievement or reasonableness of the projections, management objectives, forecasts and outlooks relating to the Proposed Transaction.

This Confidentiality Agreement shall take effect from the date of signature of this letter and shall remain in force for as long as the Information and Documents have not entered the public domain, provided that there is no breach of any of the obligations under the Confidentiality Agreement.

This Confidentiality Agreement is governed by French law.
